General Rule #22

"Load limits will be placed on all roads during inclement weather to prevent damage to the roads. No vehicles in excess of five (5) ton gross weight, will be permitted during such enforcement, except emergency vehicles or any vehicle approved by the General Manager. Penalty for violation of the load limits will be a \$500.00 fine to the member, per occurrence."

TO HELP MAXIMIZE SPACE, PLEASE FLATTEN YOUR CARDBOARD BOXES BEFORE PUTTING IN RECYCLING BINS.

A note from our recycling provider, Athens-Hocking Recycling, said that the drivers have noted some contamination in past pick-ups. They are:

1. Foil-lined Styrofoam
2. Large bulky plastic
3. Scrap metal (fencing)

WHEN IN DOUBT, THROW IT OUT

Other recycling tips:

- No half-empty jars or pizza leftovers in the box.
- Rinse your recycling – it doesn't have to be completely clean, but just rinsed.
- Items smaller than a business card can't be sorted and should go into the trash.
- Cardboard, aluminum cans, aluminum foil, steel cans and plastic bottles are worth the extra effort it sometimes takes to recycle them.
- Medical waste is NOT recyclable and is dangerous when placed in mixed recycling.
- Batteries, lightbulbs, electronics, books and scrap metal should NOT be placed with the mixed recycling. They can be taken to the Center for Hard to Recycle Materials at 9009 Sand Ridge Road at Route 13 outside of Logan.

If you went on the Social Committee's Christmas Tour of Homes, Bev and Jerry Johnson had Chicken Tortilla Soup at their home. So many members and guests who tasted the soup asked for the recipe so Bev sent it to the Echo to be printed. Enjoy!

Chicken Tortilla Soup

=====

1/4 cup butter

1/4 cup flour

3 cups chicken broth & 3 chicken bouillon cubes

1 cup milk

8 ounces Velveeta processed cheese - Cubed

10 ounces Rotel Can tomatoes with chilies

4 wholes pickled jalapeño peppers - adjust to personal hotness

2 cups Shredded chicken breasts - May also use 2- 13oz cans

1/2 teaspoon cumin

1 teaspoon chili powder

Salt & pepper - To taste

-

[1] Chop jalapeno's and Rotel, spices & bouillon in a food processor.

[2] Melt butter over medium heat in a 2qt pot. Slowly add flour while stirring, cook about 3 min stirring often.

[3] Slowly whisk in small amounts of broth & whisk in milk.

[4] Reduce heat to low, stir in Velveeta until melted. Stir in Rotel mixture, add chicken.

Thicken with corn starch mixture (I usually take some of the broth and add corn starch to it, stir and then put it in with the rest of the soup.

[5] Once soup is heated it is ready to serve. Top with shredded cheese and Tortilla strips if desired.

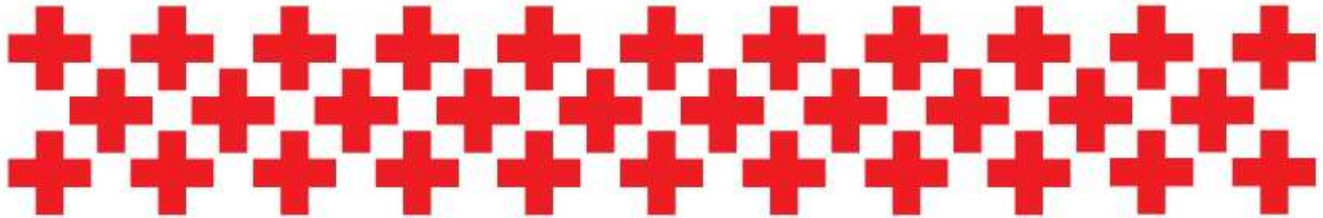

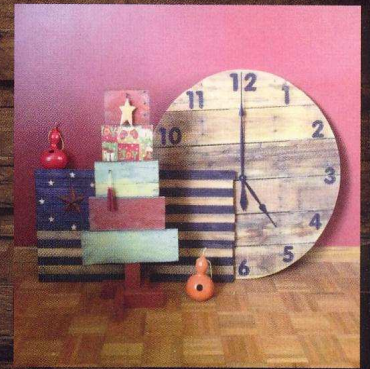

PRESIDENT'S REPORT – Greg Ptacin

A big Thank You to the members who put their homes on the Christmas tour and to the members who donated crafts and gifts. Thanks to AFY for the Christmas program for Kids and Barn bringing their horses as an extra treat.

CONSIDER MINUTES – November 21, 2017

Motion to approve the minutes was made by Frits Rizor; second by Jim Krygier – **Motion Carried**

TREASURER'S REPORT – Tom Mathews

Total Committee funds in the Vinton County National Bank on November 30, 2017 were \$88,039.72. Motion to approve made by Tom Mathews; second by Dave Miller – **Motion Carried**

Ptacin reported that when adjusting the financials for the impact of the Dam Repair and Depreciation, the YTD net profit is \$130,987.12. He explained that our financials are hard to understand because they are a mix of fund and P/L accounting. At the 12/12/17 management meeting, Randy reported that operating income was not adequate to fund several of the fund accounts. That is typical this time of year. Since many members pay their monthly assessments in one payment in January, we normally catch up on the funding by February. Approximately \$86,000 needs to be funded from the \$131,000 November YTD profit.

Ptacin said that with net profit lower than past year, the 2018 Budget will be tight. He has asked the Management Committee to review the financials on their second meeting of each month and report any issues to the Board. He directed Randy to supply a report of which accounts are funded each month. Jim Krygier reported that the food service losses are up this year due to the effort to grow that business. Sales are up and members are reporting they like the improvements. The next step is getting the expenses in line. Krygier is working on a report format for the financials so that they will be understandable by the Board and any member who wants to see them. Operating will be separated from the fund accounting. Eric Lapp suggested an information session for Board members to help them fully understand the financials. It was agreed that would be done most likely in February with the 2018 budget and new reporting format.

MANAGEMENT COMMITTEE REPORT – Chas Cross

Capital Fund: \$74,166

Depreciation Fund: \$66,877

Dam Assessment Fund: \$373,123

- Our current focus is building the budget for 2018.
- We struggled last month to locate a dump truck company to haul the rock to fix the sediment trap dam, which encountered some heavy damage while doing the dredging and the work on the North Park last year. Finally, Randy found someone and it has been installed at this time.
- We have had several gate issues during the last month; we had some antivirus software that was impeding some of the functionality at the Bremen gate and that has been removed and is no longer an issue. Likewise, we had an issue with the North gate that was not recognizing vehicles as they passed through the gate and a vehicle was hit and the mirror was broken, that issue has now been resolved at this time. We are going to be installing photo eyes to replace the underground loops as soon as possible.
- We continue to look into pricing for the new guard shack. First round pricing Randy did from a local lumber company, we are still looking at options. We have engaged a company to assist in coming up with a set of plans.
- If you have come through the guard shack lately, you will see that we have clearly marked out the hill for the sledding season.
- We are also looking at salt bins that are past their useful life, so in 2018 we need to address.
- Brenda Eveland, Assistant to the General Manager, has decided to retire; her last day will be March 2, 2018. She has over 39 years at HAH and we are very grateful for her years of service. We are currently working on how to transition after her departure.

+ Jim Lloyd questioned the use of "keep out" signs at the bottom of the dam. Chas responded that the sign wording was not the best choice but that the signs were put up due to safety concerns.

GENERAL MANAGER'S REPORT – Randy Swetnam

Delinquency totals: November 15, monthly \$37,803, Roads \$4,017; December 15, monthly \$39,103, Roads \$4,038.

- Lodge and Clubhouse WiFi – I met with Spectrum twice on upgrading the WiFi for both the Lodge and the Clubhouse, what we decided to send an engineer to evaluate what we have and what we need. I am currently waiting on that engineer to make an appointment.
- Replacement of the Lodge front door has been ongoing since April; we switched contractors and we have the scheduled to be replaced the first week of the Lodge shut down in January.
- We went with a new insurance company and we setup a new quarterly payment schedule and a savings of about \$20,000 for the Club insurance.
- The LOFS water level as of today 814.5, it has come up about a ½ inch from last week, which is not bad since we shut the valve off, because of the dock issue. With the reconfiguration of the upstream side of the dam, the docks and extension of the docks cannot bend so when you let the lake down the floating docks with the weight of the walkway with the 10 foot extension will be down in the water. The framework of the dock may freeze and will damage the docks. The other side of that are member docks and it can do the same to them. We are trying to figure out how to save the docks from damage.
- The Health Department came in and determined that we have some minor issues in the kitchen so during the shutdown Maintenance is going to be correcting some of those items.

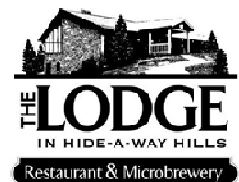
